In this regard, I am reminding (2nd time) all the students about their upcoming deadline for the payment of semester fees and they must clear off all outstanding dues i.e up to 3rd semester fees (for 2nd semester students), up to 5th semester fees (for 4th semester students) & up to 6th semester fees (for 6th semester students) within the stipulated date of 2nd July,2023 (SUNDAY) during 2nd Internal Assessments, however as per our previous notification dated 20th May,2023 we have noticed that most of the students not yet responds positively. Failing which late fine will be imposed as per the Institutional norms as well as it may affect their eligibility to appear in the upcoming even semester examination scheduled to be held from July 18, 2023.
